## INVITATION TO GENERAL ASSEMBLY 2025

*Nordic Youth Organisation (NordYouth) members are hereby invited to the General Assembly on 22nd of March 2025 in Copenhagen, Denmark.*

*The General Assembly will take place from 13:00-15:30 CET and it is possible to participate in person or online. Additionally, we will hold a workshop about inclusive collaboration from 10:30 till 12:00 CET at the same venue.*

*Our external partner organisations with an interest in NordYouth's activities are also welcome to be represented at the General Assembly.*

### **Key points of the General Assembly agenda:**

- Annual report 2024, updates about the 2024 activities, activity plan 2025
- Overview of final accounts of 2024 and Budget for 2025
- Membership and partnership issues
- Election of Chairperson. The election is for 2 years.
- Election of Auditor and Internal Auditor.

Please note that NordYouth's statutes will be addressed and possibly adjusted at this General Assembly. These changes concern the registration and address of the organisation, signing rights, and are based on the practical needs of the organisation. The board will inform the member organisations of the specific change proposals in the statutes before the meeting.

### **Voting rights and participation format**

Organisations with full membership in NordYouth are entitled to two (2) votes at the General Assembly, which should be used by two separate persons.

Participation and voting can be done physically or online, but we are hoping to welcome many of you in person!

### **Material**

According to our statutes, members should send material they wish to process at the General Assembly to the secretariat at least 6 weeks before the General Assembly, which means no later than the 8th of February 2025. Proposals and announcements from member organisations can be sent in a freely formulated email to NordYouth secretariat at [info@nordung.org](mailto:info@nordung.org). NordYouth's secretariat will send out the meeting material no later than a month before the meeting.

### **Chairperson nominations**

All member organisations are able to put forward Chairperson candidates. For nomination of Chairperson candidates, please send the signed mandate from the proposing member organisation, the candidate's motivation letter and relevant experience/information to the Secretariat at [info@nordung.org](mailto:info@nordung.org). We advise the Nominations to be sent in latest by 15th of March 2025, but it is possible to nominate candidates until the General Assembly opens.

### **Financial rules and practical arrangements regarding travel, meals and accommodation:**

- NordYouth pays travel reimbursement for meeting participants from Greenland to maximum 850€. The actual payment cannot exceed the actual travel costs, and it can be paid for one participant or distributed over several.
- Participants from all other countries and self-governing areas receive no travel reimbursement.
- NordYouth provides lunch and coffee/tea during the General Assembly.
- Meeting participants or their organisations cover the costs for other meals and accommodation.
- These rules also apply to board members who attend the General Assembly.
- NordYouth will send the meeting address and accommodation suggestions in January 2025.

### **Language**

The meeting language(s) is/are chosen so that the content can be understood by all participants, which in practice means the meeting will be held in Scandinavian and/or English.

### **Workshop**

During this workshop, we will be discussing our work plan for 2025 and explore ways to increase inclusive approach in our collaboration within the NordYouth network. This workshop is held from 10:30-12:00 CET at the General Assembly venue.
